Ownership and registration

The breeder guarantees that they are the legal owner of the puppy and have the right to sell it. The breeder will provide the necessary registration documents, if applicable, to the buyer within a reasonable time after purchase.

Transfer of ownership

The transfer of ownership will take place upon receipt of the full payment by the breeder. The buyer agrees to provide a safe and suitable environment for the puppy, including proper shelter, nutrition and veterinary care.

Return policy

I/we agree, that if the puppy needs to be returned to the breeder, for whatever reason. I/we will contact the breeder immediately, and then return the puppy back to them, or keep the puppy until it can be collected. If the puppy has been rehomed, they will receive £250. I/we agree that I/we will not rehome the puppy, without the breeder's permission. This contract must accompany with all other official documentation you receive with the puppy, must be passed on to the breeder if returned or rehomed. It is essential that the puppy is taken to the veterinarian in the next 72 hrs (excluding weekends or bank

holidays) at the buyers expense, for a health check, and to plan for vaccination (if not already done) Should there be any problems not attributed journey home (travel sickness) or change of diet or water (tummy upset) and render the puppy unfit for sale as a companion, a full refund will be given, on the production of a full veterinary report.

Entire agreement

I/we will provide the best possible care and cause no unnecessary suffer of any kind at any time.

I/we undertake to contact the breeder for any advice on health, welfare and breeding, in first instance, or if circumstances change.

The puppy will have been wormed at least three times, before leaving it's mother. Depending at what age you have your new puppy, you will need worming monthly until 6 months of age, when you can change to adult worming schedule, which could be 2 or 3 times a year. Your puppy will have been microchipped before leaving the breeder.

The above puppy will have been vet checked and is in sound mind and limb at the point of sale. I/we as breeder will have examined the puppy and as breeders appear to be uninjured and apparently in good health. The breeders have by a good breeding code of practice endeavour to reduce the possibility that the puppy may in the future be seriously affected by an inherited defect which is not apparent at the time of sale. Five weeks of insurance will go with the puppy, to be either continued or cancelled with the insurer. It is strongly recommended that further insurance be taken out with the insurance you prefer of your choosing
